Whereas, the Jammu and Kashmir Services Selection Board, vide Indent No. Horti/56/2017 dated 15-10-2020 followed by Horti/56/2017 dated 14.01.2021, received (01) one Post of Welder with Pay Level-2 (19900-63200) from Horticulture Department, advertised vide Notification No. 01 of 2021 dated 03.02.2021, under Item No. 029 as per the following category-wise break up:

whereas, the requisite qualification for selection against the post, as per the Indent, is given as under:

***"Matriculate or its equivalent with ITI Training in Automobile/ Mechanical /Electrical/Welding Trade"***

whereas, the J&K Services Selection Board, accordingly, conducted an (OMR) based written examination for the post of Welder on 06.02.2025. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/6/2025-06 (7644391) dated 16.04.2025, published the Result/Score-sheet of the candidates.

whereas, after the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification vide Notification No. JKSSB-COE0EXAM(UT)/7/2025-03 (7646318) dated 30.04.2025, at both Jammu & Srinagar on 07.05.2025, followed by supplementary DV on 18.06.2025.

whereas, the Selection Committee, upon careful scrutiny of the Indents/advertisements, prepared the Provisional Selection List for the said post in accordance with the Merit/ Eligibility of the candidates as per the extant rules, which was accordingly placed before the board in its 326<sup>th</sup> meeting, held on 18.11.2025, which after due deliberations and consideration of the matter, approved its



notification and the same was notified vide Notification No. JKSSB-Scry/19/2025-06 (E-7731541) dated 04.12.2025, seeking objections from the candidates within a period of 10 days from the date of issuance of the notification; and

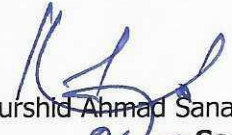
whereas, pursuant to the above, only one representation was received in the Board, which was examined as per the available record/ extant guidelines, for necessary action; and

whereas, the proposal for notifying the Final Selection List, for the aforesaid **(01) one post** of Welder of Horticulture Department advertised vide Notification No. 01 of 2021 dated 03.02.2021, as prepared by the concerned Selection Committee, was placed in the Board in its 348<sup>th</sup> meeting held on 30.04.2026, which after due deliberation on various aspects related to the instant selection, approved its notification.

Now, therefore, the Final Selection List of the candidate for **(01) one post** of Welder, Horticulture department, advertised vide Notification No. 01 of 2021 dated 03.02.2021, is hereby notified as per "**Annexure-A**" to this Notification. It is further notified that:

- i. The Final Selection List shall be subject to outcome of the OAs/Writ Petition(s), if any, pending in the competent court of law.
- ii. This shall also be subject to the outcome of any pending inquiry, involving candidate(s), figuring in this Final Selection List.
- iii. Formal recommendation to the concerned Indenting Department shall be forwarded separately.
- iv. The selection of the candidate has been made on the basis of Self-declaration/ certificates submitted by him and if at any stage, it comes to light that he has submitted false information or has secured selection on the basis of fake or invalid documents/ certificates, the selection shall be liable to cancellation at any stage.
