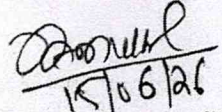

1. Whereas, the J&K Public Service Commission conducted the Written Examination (Preliminary) for filling up of posts of Prosecuting Officer (G) in J&K Home Department, on 31.05.2026; and
2. Whereas, the Provisional official key(s) in respect of Paper-I and Paper-II were notified and uploaded on the official website of the Commission for information of the candidates vide Notification No. PSC/Exam/S/2026/53 dated 31.05.2026, inter-alia notifying that, if any candidate feels that the key(s) to any of the question(s) are wrong/incorrect, he/she may prefer an objection on the prescribed proforma to the Controller of Examinations within a period of three days from the date of notification along with documentary proof /evidence and the fee of Rs.500/- per question; and
3. Whereas, in response to the said notification, objections were received by the J&K Public Service Commission against Provisional Answer Key issued in respect of Paper-II whereas no objection has been received against Paper-I; and
4. Whereas, all the objections were referred to the Experts as envisaged in Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022, as amended from time to time, for Expert opinion; and
5. Whereas, the Experts have recommended changes in the Provisional Answer Key in respect of Paper-II;

Now, therefore, in view of the above and on the basis of opinion of the Experts, it is hereby notified that:-

- a) The changes recommended by the Experts are hereby adopted and the Final Answer Key(s) are annexed to this notification as **Annexure A and B** in respect of **Paper-I and Paper-II** respectively. In terms of Rule 10 (d) of the J&K Public Service Commission (Conduct of Examination) Rules, 2022 as amended upto date, the marks allocated to the deleted questions ***shall be individually added to the marks secured by the individual candidates to ensure that the mark(s) allocated for the question paper as a whole remain unchanged,*** at the time of calculation/compilation of award sheet before the declaration of the result;
- b) The amount deposited @ Rs 500/- per question is also hereby released in respect of genuine/correct representations and same shall be transferred through RTGS to individual account of candidates.

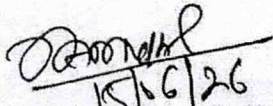

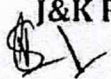
