Whereas vide advertisement notice No. 01 of 2026 dated 19-01-2026, for engagement of different categories of posts under One Stop Centre (OSC) Ramban and District Hub for Empowerment of Women (DHEW) Ramban on purely temporary/contractual basis, as per fresh guideline issued by the Ministry of Women and Child Development, GoI; and

Whereas, the District Social Welfare Department Ramban, advertised the aforesaid posts, vide Notification No. 01 of 2026 dated 19-01-2026, for seeking applications from the eligible candidates.

Whereas, the schedule of the scrutiny/verification/merit calculation committee Documents Verification (DV) of the candidates falling under the consideration zone were notified vide No. DSWO/R/2026-27/331-34 Dated 30-04-2026 and same was conducted on 12-05-2026 and the list of shortlisted candidates has been published in public domain for inviting objection if any candidates/general public and adequate time was provided for filing objection

upto 25-05-2026 & in this context no objections/claims have been received by the concerned office until the stipulated time period.

Whereas this office vide no. DDCR/plg/2026-27/2124-30(A) dated 09-06-2026 and this office has issued an order of constituted interview committee for the above said posts for conducting of interview on 17-06-2026 in the conference Hall of the District Administrative Complex Ramban.

Whereas, the Selection Committee for conducting interview and preparing the Selection List for the above said posts. The Selection Committee so constituted conducted the interview and prepared the final selection list in accordance with the Merit/Eligibility of the candidates and on the basis of principle of merit-cum-preference as well as experience as per advertisement, which after deliberations and having regard to all the aspects of the selection, approved its notification.

Now, after taking into consideration all the aforementioned factors, the Final Selection List for the posts of Financial Literacy in District Hub for Empowerment of Women (DHEW) Ramban and Multi-Tasking Staff (MTS) in One Stop Center (OSC) Ramban advertised vide Advertisement Notification No. 01 of 2026 dated 19-01-2026 is hereby notified as per "Annexure-A" to this notification.

Now, therefore, the selected candidates are advised to report in the office of District Social Welfare Officer Ramban. (Nodal Officer OSC and DHEW) within 07 days along with the requisite documents against each post for temporary engagement in OSC and DHEW Ramban.

In case any candidate fails to report within the said period, the engagement order shall be cancelled.

The engagement of candidates shall be subject to the following conditions:

1. The engagement shall be purely on contractual basis with a monthly consolidated remuneration already mentioned in the advertisement notice/ as per guidelines.
2. The engagement, being purely temporary/contractual arrangement, shall be terminable if the performance is not satisfactory as assessed by District Level Committee headed by District Magistrate/ District Development Commissioner Ramban or if the candidate indulges in any antinational/ anti-social activity/misadventure.
3. There shall be no rights to seek permanent absorption in any department of regulation of any sort (Affidavit for the same sworn before the Judicial Magistrate 1st Class is needed to be executed upon before joining).
4. The selection shall be subject to verification of all original documents from concerned University and also Character from the competent authority and in case any adverse report is received regarding the documents produced by the candidates, the appointment of the candidates shall be

terminated ab-initio. The concerned DDO shall not draw the remuneration till all the verification reports of the qualification and antecedents are received from the concerned agencies/institutions.

5. The DSWO Ramban (Nodal Officer OSC and DHEW) shall allow the candidates to join after the production of the following certificates in original:

Academic Qualification Certificate.

- A. Domicile certificate.
- B. Medical fitness certificate.
- C. Qualification certificates
- D. Experience certificates
- E. Character Certificate from concerned Police Station
