Whereas Government of J&K adopted the Scheme of Central Assistance for one time settlement of displaced families of PoJK(1947) and Chhamb (1965 & 1971) under Prime Minister's Development Package-2015 approved by the Ministry of Home Affairs ,Government of India and notified the same vide Govt. order No.22-DMRRR of 2017 dated 27.03.2017, the timeline of which has been extended from time to time and the sunset date of the scheme was notified as 31.03.2026; and

Whereas the Ministry of Home Affairs, Government of India, vide communication No. 12013/01/2020-J&K Dated: 25.05.2026 has conveyed approval to the extension of the timeline of the scheme of Central Assistance for One time settlement of displaced families of PoJK (1947) and Chhamb (1965 & 1971) settled in the Jammu and Kashmir under the Rehabilitation package upto 30.09.2026.

Accordingly, sanction is hereby accorded to the extension of the timeline of the scheme of Central Assistance for one time settlement of displaced families of PoJK (1947) and Chhamb (1965 & 1971) settled in Jammu & Kashmir, from 31.03.2026 to 30.09.2026 within the approved outlay of Rs. 2000 Crore with the stipulation that the scheme shall not continue beyond sunset date i.e., 30.09.2026.
