In continuation of Order No. 215-LA(GAD) of 2022 dated 19.07.2022, sanction is hereby accorded to the constitution of the District Level NCORD Committees in respect of the five newly created districts, namely Sham, Nubra, Changthang, Zaskar, and Drass, comprising the following members, with the objective of strengthening the support and coordination mechanism among various stakeholders through the NCORD framework for the focused resolution of policy and operational issues.

Terms of Reference of the District Committee:

1. Exchange of intelligence/ information about trends of drug trafficking.
2. Monitoring of illicit cultivation of poppy or cannabis crop in the district.
3. Monitoring the progress of investigation in cases having cross-state implications

4. Promoting anti-drug abuse awareness, especially in schools and colleges.
5. Conducting awareness programmes in the regions affected by illicit cultivation of Narcotic crops in the District.
6. Implementing alternative development programmes in areas affected by illicit cultivation of narcotic crops in the district
7. Assessing the requirement of equipment of drug detection and submitting proposals for requisitioning of the same.
8. Supervision of drug de addiction and rehabilitation centers in the District.
9. Any other issued, as deemed fit.

Frequency: The District Level NCORD Committee shall meet at least once every month.

Co-opted member - The proposed Chairperson of the District NCORD Committee may co-opt representatives of Departments/Organizations concerned as members based on the requirement as "Special Invitees".

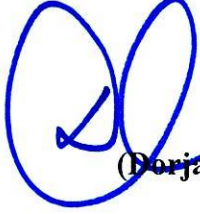
