Sanction is hereby accorded to the advance drawal of an amount of ₹15.20 lakh (Rupees Fifteen Lakh and Twenty Thousand only) in favour of the Director, AYUSH, J&K, in terms of S.O. 157 of 2026 dated 05.06.2026, for onward disbursement of the Grant-in-Aid to the concerned AYUSH Boards under the relevant Detailed Heads for the Financial Year 2026-27.

The advance drawal shall be subject to the following conditions:

1. The amount shall be utilized strictly for the purpose for which it is sanctioned and under the relevant Detailed Heads.
2. The Director, AYUSH, J&K shall ensure onward disbursement to the concerned Boards in accordance with the applicable rules, guidelines and sanctioned provisions.
3. The drawal and utilization of the amount shall be subject to observance of all applicable financial rules, codal formalities and instructions issued by the Finance Department/Government from time to time.
4. Proper accounts of the amount drawn and utilized shall be maintained and the Utilization Certificate/Statement of Expenditure, as applicable, shall be furnished within the prescribed period.
5. Any unspent balance shall be surrendered/refunded to the Government Treasury as per the applicable rules.
6. The Director, AYUSH, J&K shall be personally responsible for ensuring that the amount is not diverted or utilized for any purpose other than that for which it is sanctioned.

The expenditure shall be debitale to the relevant Detailed Heads under the Grant-in-Aid provisions of the Health and Medical Education Department for the Financial Year 2026-27, subject to availability of funds and observance of prescribed budgetary controls.
