- ii. The placement/assignment of charge is subject to superior claim of any left-out officer if found genuine or as outcome of legal proceedings pending before Hon'ble Court.
- iii. In case the requirement of the borrowing organizations ceases or the officers deputed by the Jal Shakti Department are repatriated, the junior most officers shall be reverted from the higher posts and shall not have any claim of benefit of assignment of temporary charge of the higher post.
