In suppression of Government Order No. 1262-JK(GAD) of 2022 dated 19.10.2022 issued on the subject, Union Territory Project Monitoring Group (UT PMG) for facilitating coordinated monitoring and expeditious resolution of issues relating to infrastructure and other investment projects in the Union territory of Jammu & Kashmir with threshold cost of Rupees Five Crore (₹ 5.00 Cr) and above, in accordance with the framework and operational guidelines issued by the Department for Promotion of Industry and Internal Trade (DPIIT), Government of India, is hereby re-constituted as under:-

Terms of reference(ToRs):

- 
- i) To review and monitor the issues related to major projects, schemes, programmes, flagged/uploaded on the PMG Portal.
 - ii) To facilitate the resolution of inter-departmental and project-specific bottlenecks affecting the timely implementation of projects.
 - iii) To coordinate with Central Ministries, the Department for Promotion of Industry and Internal Trade (DPIIT), Administrative Departments, District Administrations, and Project Proponents to ensure the expeditious resolution of issues.
 - iv) To periodically review the status of issue resolution.
 - v) To recommend appropriate measures for the removal of systemic, procedural, and policy-related bottlenecks impacting project implementation.
 - vi) To review and approve periodic reports on project progress, issue resolution, and overall implementation status.
 - vii) To co-opt any officer, expert, or other stakeholder, as deemed necessary, for the effective discharge of its functions.

Further, it is ordered that the Planning, Development & Monitoring Department (PD&MD) shall be the Nodal Department for coordination, implementation and operationalization of the Union Territory Project Monitoring Group (UT PMG) Portal. The Planning, Development & Monitoring Department shall, inter alia:

1. Act as the nodal agency for liaison and coordination with DPIIT, Government of India, and other stakeholders.
2. Monitor projects registered on the UT PMG Portal and facilitate resolution of issues affecting their implementation.

3. Coordinate meetings of the UT PMG and ensure follow-up of decisions taken therein.
4. Manage and maintain the UT PMG Portal and related reporting mechanisms.
5. Undertake such other functions as may be required for effective implementation of the PMG framework.
