Sanction is hereby accorded to the placement of Mr. Sunil Kumar Khajuria Principal HSS Pallanwalla Jammu as In-charge Chief Education Officer & Equivalent in his own pay and grade with immediate effect.

The above placement shall be subject to the following conditions:-

- The placement shall not confer any preferential claim or right to the officer for seeking regularization/confirmation, which shall be considered strictly as per rules by DPC/JKPSC.
- The placement shall be subject to the outcome of writ petition(s), if any, pending before any competent Court(s) of law.
- The officers shall submit an undertaking to the concerned Director stating that in case his/her service particulars/academic credentials are found fake/forged/tempered or issued by any un-recognized university, his/her placement shall be deemed to have been cancelled ab-initio.
- In case of an adverse report from ACB/GAD (vigilance)/CID or any concerned agency, his placement shall be deemed to have been cancelled, ab-initio.
- The officers shall join/report his new place of posting(s) within 10 days from the date of issuance of this order and in case of failure to join within the stipulated time period, his placement shall be deemed to have been cancelled ab- initio, without any further notice.

Consequent upon the above and in the interest of administration, the following transfers/postings/adjustment is hereby ordered with immediate effect:

- Mr. Subash Chander Gupta I/c Chief Education Officer, Udhampur is transferred and posted as Chief Education Officer, Jammu.
- Mr. Sunil Kumar Khajuria, Principal HSS Pallanwalla Jammu upon his placement as I/c Chief Education Officer is posted as Chief Education Officer, Udhampur.

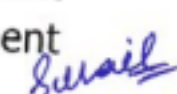
