Terms of reference:

- i. No member of the governing body or her/his relative shall be a beneficiary of the fund during the period such member holds office.
- ii. The tenure of the social workers shall be not more than three years.
- iii. The members shall be given TA/DA for meeting, as per the actual vouchers, subject to a ceiling of Rs. 2000/- per day.
- iv. The Governing Body/Approval Committee shall meet at least once every quarter.

Terms of Reference:

- i. To receive and scrutinize applications for assistance under the fund.
- ii. To ensure that complete applications that meet all threshold eligibility requirements shall be evaluated for further submission to the Governing Body/Approval Committee for necessary approval and support.
- iii. To ensure that only such applications which are not covered/supported under any other scheme/programme shall be submitted to the Governing Body/Approval Committee.
